NOTICE TO MEMBERS - CALL FOR COUNCIL NOMINATIONS

2010/12

In accordance with **Clause 101** of the Constitution of the Optometrists Association Australia (NSW and ACT Division), **nominations** are called for the positions of **PRESIDENT** and **SEVEN COUNCILLORS** for the 2010/12 term of the Council.

Regarding nominations, please carefully note the following:

- ▶ Nominations must be made in writing.
- ▶ Nominations may only be made by **honorary life members and financial ordinary members (full time practice, partial practice, minimal practice, academic, new graduate and recent graduate members)**.
- ▶ Nominations **must be signed** by the proposer and the seconder and contain the consent of the member being nominated.
- ▶ Only **honorary life members and financial ordinary members (full time practice, partial practice, minimal practice, academic, new graduate and recent graduate members)** may be nominated.

When lodging a nomination, please ensure that the following details are complete:

- ◆ The full name and membership category of the **nominee, proposer** and **seconder**
- ◆ The signature of the **proposer** and the **seconder**
- ◆ The consent of the candidate and the office for which the candidate is nominating [ie President or Councillor]

NO LATER THAN THE LAST MAIL ON MONDAY 20 SEPTEMBER 2010

A candidate may be nominated for election for more than one office, but a separate nomination form must be lodged for each office for which a particular candidate is proposed.

Should there be more than one nomination for the position of President and/or more than three nominations for the positions of Councillor, then a **postal ballot** shall be conducted in accordance with **Clause 101**. Results of the nominations / ballot will be announced at the Annual General Meeting of the Association to be held on Monday 15 November 2010.
